SUB: OUTCOME OF BOARD MEETING HELD ON 7<sup>TH</sup> OCTOBER 2019

Pursuant to the provisions of the Listing Regulations, we wish to inform you that the Board of Directors of the Company at its meeting held today, on 07.10.2019 (commenced at 5:00 p.m and concluded at 06:30 p.m.) has, inter-alia, transacted the following businesses:

1. We regret to inform that the Audited Standalone Financial Results and Audited Consolidated Financial Results for Quarter / Year ended 31.03.2019 under regulation 33(3) of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015 and Un-audited Financial Results of the Company for the Quarter ending 30th June, 2019 were deferred due to continuing problem of labour unrest/dispute and electricity disconnection in Sonepat Unit of the Company, due to which Financial Results of Sonepat Unit is not yet prepared and after deliberation, the Board of Directors have directed the Finance head of Sonepat Unit and Management Committee of Sonepat Unit to take necessary steps and resolve the issues at the earliest possible and complete preparation of financial results.

Further, The Company has got extension for 1 month 15 days from Registrar of Companies(ROC) for holding 68<sup>th</sup> Annual General Meeting of the company for financial year 2018-19. An understanding with the labour is being arrived at, to settle the ongoing dispute with the Company. The board of directors has decided to apply to Registrar of Companies for seeking further extension of time for holding 68th annual general meeting by 1 month 15 days.

2. The matter related to declaration of Dividend has been deferred as financial results for 31st March 2019 have been delayed.
