This is to inform you that the registered office of M/s Atlas Cycles (Haryana) Limited is situated at Industrial Area, Atlas Road, Sonepat – 131001, Haryana, India.

Already there is a case of oppression and mismanagement under S. 397, 398, 399, 402 and / or other provisions of Companies Act 1956 / Companies Act 2013 titled "Vikram Kapur & Ors. Versus Atlas Cycles (Haryana) Ltd. & Ors." is being pursued before the National Company Law Tribunal, erstwhile Company Law Board since March 2015.

In the Annual Report of last financial year 2014-15, a sum of Rs 3,41,07,212/-was shown recoverable. The said amount was recoverable against the unauthorised payment of rent made from the accounts of the Company for residential accommodation availed by Mr Vikram Kapur and Mr Angad Kapur. Out of said amount, a sum of Rs 1,40,00,000 (Rupees One Crore Forty Lakhs only) was received into the accounts of the Company on 30th September 2015 and the balance recoverable amount is Rs 2,01,07,212/-. The Company has already initiated appropriate legal proceedings against Mr. Vikram Kapur and Mr. Angad Kapur for misappropriation of said amount and the matter is pending adjudication in the court of Magistrate, Saket Courts, New Delhi.

Company Secretary has also raised concerns as to non-cooperation and non-provision of required information(s) by the Accounts and Finance Team of Sonepat Unit and other departments of Sonepat Unit of the Company. All the Secretarial and legal records relating to the office of Company Secretary cum Compliance Officer are kept at the registered office of the Company.
